AMEND RESOLUTION #00-1124 RELATIVE TO THE VACATION OF AN ALLEY ALONG SYCAMORE STREET IN HAMILTON TOWNSHIP

The Board met this 18th day of January 2001, in the Commissioners' Meeting Room, to consider amending Resolution #00-1124 adopted June 29, 2000, to approve the vacation of an alley along Sycamore Street in Hamilton Township.

Robert Price, County Administrator, explained that the vacation approved in June reverted the vacated property to the adjacent property owners within the platted subdivision only and it has now been determined that the reversion was incorrect and should have been divided equally among all adjacent property owners, not just the ones within the platted subdivision.

Commissioner Kilburn explained the vacation procedure and requested Bruce McGary, Assistant Prosecutor, to explain how this error came about.

Mr. McGary stated that upon research, the statute stated that the alley must be divided evenly among all abutting property owners. He then stated that in the past, it has been the philosophy that when property was vacated within a subdivision, the property should revert back to the property which originally granted the land for public use. He then stated that the case law clearly shows that philosophy to be incorrect.

Commissioner Kilburn stated his opinion that the law is not fair and the land should go back to who gave it in the beginning.

James Snider, 208 Broadway, Maineville, Ohio, stated his protest to the amendment of the vacation resolution claiming that he has plans for this land which was given to them by the Board in June of 2000.

Commissioner Kilburn stated he feels the Board did not go by the law and should amend the vacation resolution to comply with the law.

Commissioner Kilburn requested a written opinion from the Prosecutor's Office and it was then determined that the Board already has said written opinion.

Mr. Crisenbery moved to amend Resolution #00-1124, being seconded by Mrs. South. Upon discussion, Commissioner Kilburn stated his desire to have a formal resolution to read into the record. Mr. Crisenbery then withdrew his motion and Mrs. South withdrew her second.

On motion, the Board recessed the public hearing in order for Mr. McGary to prepare a formal resolution.

On motion, the Board reconvened the meeting and Mr. Kilburn read a draft resolution to amend resolution #00-1124.

Upon discussion, the Board resolved (Resolution #01-131) to amend Resolution #00-1124 adopted June 29, 2000, to approve the vacation of an alley along Sycamore Street in Hamilton Township and to divide the vacated property equally between all adjacent property owners.
