DISCUSSIONS

Neil Tunison, County Engineer, was present for a work session to discuss the Drake Road Widening and Realignment Project.

Mr. Tunison stated that the improvements and widening of Drake Road in Turtlecreek Township were completed; the Clearcreek Township Trustees approached him about widening the portion of Drake Road from the township line to State Route 122. The proposed plan would widen the remaining portion of Drake Road along the west side and would also include the realignment of the intersection of Drake Road and S.R.122. The intersection is currently a 55 degree left turn angle which makes it difficult for buses and larger vehicles to navigate.

Commissioner Kilburn asked what percentage of the total project cost is for the intersection realignment and Mr. Tunison stated that the project has been approved for Ohio Public Works Commission (OPWC) funding. The total cost for the project is \$325,000, of which OPWC will contribute \$159,000 with Warren County and the Clearcreek Township Trustees funding the local match. The cost for the realignment is approximately \$185,000.

Commissioner Young asked what the rationale is for widening on the west side of the road as opposed to the east side. Mr. Tunison estimated there would be a net additional cost of \$30,000 to \$40,000, to go to the east side due to the additional grading and fill that would be needed. That estimate takes into account the donation of a property easement on the east side from Mr. Paul Herdman.

Mr. Kilburn asked where we stand in the process of purchasing easements from the property owners on the west side of the road. Mr. Tunison stated that staff from his office has begun talking to the property owners and has encountered numerous questions regarding the project.

Commissioner South asked for a show of hands, of the Drake Road property owners present, as to how many would prefer the project on the east side of the road. All were in favor of that option.

Mr. Young stated that it would be a cleaner project, with much less impact on the property owners to proceed with widening on the east side. Mr. Kilburn and Mrs. South agreed.

Mrs. South stated her desire for a confirmation on the estimated cost of the project and stated if it going to be in the \$40,000 ball park that it is money well spent.

Mr. Kilburn questioned what assumptions are being made on what the easements are going to cost.

Mr. Tunison stated that his office estimates that the cost per easement, based on appraised value, would be \$1,000 to \$2,000 and that there are 15 property owners.

Mr. Kilburn stated his opinion that the estimate is low and could potentially be much higher if several of the property owners would decide to take legal action to get what they feel is an appropriate compensation for their property.

Upon discussion, it was agreed to proceed with the project, with the widening to be on the east side of the roadway rather than the west.

The Board acknowledged signature and sending of a letter to the Ohio Department of Job and Family Services relative to the need for change in regulations for food stamp eligibility.

Upon motion the meeting was adjourned.
