On motion, upon unanimous call of the roll, the Board accepted and approved the consent agenda.				
Sheriff Sims was present to request the Board's approve the submittal of a grant application to apply for Stimulus Funds to be utilized to fund a school resource officer position within the Kings School District.				
Sheriff Sims stated that the grant will prove three years of funding and requires a fourth year to be funded by the local entity. He stated that Deerfield Township and the Kings Local School District have agreed to split to cost of funding the fourth year. He then stated that no general fund dollars will be utilized due to this grant.				
Upon further discussion, the Board resolved (Resolution #09-512) to approve and authorize the submittal of a Grant Application on behalf of the Warren County Sheriff's Office.				
Mike Yetter, Zoning Supervisor, was present for the site plan review application of Salvation Army Camp Swoneky in Washington Township.				
Mr. Yetter explained the request to construct an addition to the maintenance building on the west side and along the north side of the building, construct an 11 x 66 covered concrete floor.				
Mr. Yetter then reviewed the comments from all agencies and officials and stated the recommendation to approve the site plan review application subject to three conditions.				
Upon further discussion, the Board resolved (Resolution #09-513) to approve the site plan review application subject to three conditions.
