PUBLIC HEARING REZONING APPLICATION OF JOHN ENTWISLE TO REZONE APPROXIMATELY 1.5 ACRES IN UNION TOWNSHIP FROM HEAVY INDUSTRY "M-2" TO RURAL RESIDENCE "R-1"

The public hearing to consider the rezoning application of John Entwisle, agent for owner of record, to rezone approximately 1.5 acres located at 3490 Bunnell Road in Union Township from Heavy Industry "M-2" to Rural Residence "R-1" was convened this 11th day of January 2011, in the Commissioners' Meeting Room.

Mike Yetter, Zoning Supervisor, reviewed the recommendation from the Rural Zoning. Commission and the Regional Planning Commission to approve the rezoning application. He stated that this is a straight rezoning request and not a planned unit development so therefore, there are no conditions of approved required.

Stan Williams, Regional Planning Commission, stated that this rezoning application is consistent with both the Warren County Land Use Plan as well as the City of Mason's land use plan which is adjacent to the property.

Eric Entwisle, property owner, stated that the purpose of the rezoning application is to refinance the property. He stated that this request will also bring the zoning current with the actual use.

Upon further discussion, the Board resolved (Resolution #11-0077) to approve the rezoning application.

J. William Duning, Agent to annex 25.3142 acres to the Village of South Lebanon pursuant to Ohio Revised Code Section 709.023 (Expedited Type 2 Annexation) was present along with representatives from the Village of South Lebanon, representatives from Hamilton Township, Bruce McGary, Chief Deputy Prosecutor, and interested citizens, for the Board to discuss the annexation petition.

Mr. McGary stated that it is the requirement of the Board of Commissioners to determine whether the seven conditions required for approval of the annexation have been met. He then reminded the Board that this is not a public hearing and is administrative in nature. He then discussed the review comments from the Tax Map Department as well as the items listed in the Objection Resolution from Hamilton Township.

There was discussion relative to the number of owners being included in the petition not including the School Board or ODOT. There was also discussion relative to the signatures on the petition not including a date.

Mr. Duning stated that 100% of the property owners according top law have signed and been included in the petition. He then pointed out the statement in the petition that authorizes him, on behalf of the property owners, to make any amendments, corrections or alterations to the petition as required.

Mr. Duning stated that the property owners signed the petition approximately one week prior to the filing with the Board of Commissioners. He stated his opinion that he can legally date the signatures on their behalf. He then stated that the petition for annexation contains all matters required by law and requested the Board to approve the annexation petition.

Jim Smith, Mayor of South Lebanon, stated that the Village of South Lebanon has had a school presence for over 200 years. He stated that South Lebanon had a school prior to Warren County even becoming a county. He then stated that he was on the review committee which sited the new elementary school and that the only reason it was sited in Hamilton Township was because there was no suitable land available within the Village at the time. He stated that the School District is neutral to the annexation and then stated the presence of two (2) retired school teachers to show their support for the annexation of the school.

Commissioner Young stated his concern relative to a new tax being required on the employees within this school building without any say in the matter.

Commissioner Young exited the meeting at 10:30 a.m. due to a prior obligation.

Commissioner South acknowledged a telephone call of Township Trustee Becky Ehling stating his inability to be at the meeting today and stating her opposition to the annexation.

Warren Ritchie, attorney for Hamilton Township, reviewed the objections on behalf of Hamilton Township. He then stated that due to time constraints, the township must adopt an objection resolution prior to the any resolution for services being filed by the municipality.

Mr. Ritchie stated his opinion that even through a governmental entity does not have a vote in the annexation; they are still an owner and should be included in the notices. He then stated that no one from the school district was notified of the public hearing and that it is grossly unfair to the school district. He then requested the Board to reject the annexation petition.

Mr. McGary read aloud the section of the Ohio Revised Code relative to ownership and it was determined that governmental entities are not counted in the petition nor considered owners.

Commissioner South acknowledged the need for legislation that includes notice to all property owners, including governmental entities, to provide the fairness discussed by Mr. Ritchie.

There was discussion relative to the fact that since this is not a public hearing, nothing discussed today is part of the record of proceedings. It was determined that Mr. Duning will file an affidavit relative to the date of signing of the petition by the property owners.

Upon further discussion, on motion, upon unanimous call of the roll, the Board continued this discussion to January 18, 2011, at which time the Board intents to render a decision upon the annexation petition.

Upon motion the meeting was adjourned.
