DISCUSSIONS

On motion, upon unanimous call of the roll, the Board entered into executive session at 9:02 a.m. to discuss personnel matters pursuant to Ohio Revised Code Section 121.22 (G)(1) and union negotiations pursuant to Ohio Revised Code Section 121.22 (G)(4) and exited at 9:36 a.m.

On motion, upon unanimous call of the roll, the Board accepted and approved the consent agenda.

On motion, bids were closed at 9:15 a.m. this 13th day of March and the following bids were received, opened and read aloud for Oregonia Rd. Bridge Rehab for the Warren County Engineer's Office:

Neil Tunison, Warren County Engineer will review bids for a recommendation at a later date.

Michael Shadoan, Facilities Management Director, was present along with Brian Hogan, Garland Design Build, and presented a PowerPoint presentation relative to the conditions of

roofs on various county owned buildings; said presentation attached hereto and made a part hereof.

Paul Kindell, Director of Telecommunications, was present to discuss Warren County's switch from an analog to a digital radio system.

Mr. Kindell introduced Daryll Anderson, Ohio MARCS (Multi Agency Radio Communication System).

Mr. Anderson stated that the MARCS system is a statewide system that is 15 years old and is currently in the process of being upgraded. He stated that MARCS already has the same zone controller that Warren County is considering purchasing. He stated that the zone controller is located near the Ohio State University and is currently operating at 1% capacity. He stated that Warren County could partner with MARCS and utilize their zone controller with Warren County's existing towers being incorporated into the MARCS system. He stated that Warren County could take over ownership of the two state-owned communication towers located in the county. He then stated that this partnership would save both partners money and provide maximum interoperability.

Commissioner Young stated that Warren County supports regionalism and there are two paths the county can pursue:

- 1. Warren County can partner with the State of Ohio; or
- 2. Warren County can buy the models and set up the infrastructure and other entities could partner with us.

Mr. Anderson stated that the State could be ready almost immediately should Warren County decide to go that route.

Commissioner South questioned why other counties would not join the network if the capacity exists.

Mr. Anderson stated that some are comfortable with what they currently have and may not want to surrender control to the State.

Mr. Young stated that the number one priority of Warren County government is public safety and that he sees no problem with conceptually partnering with the State. He then stated his opinion that it doesn't make sense to duplicate what the State can offer if it will save the county money.

Upon further discussion, the Board directed Mr. Kindell to submit a letter to initiate negotiations to develop a partnership agreement with MARCS.

Mike Yetter, Zoning Supervisor, was present along with Stan Williams, RPC, for the site plan review application of David Brown in Union Township.

Mr. Yetter stated that Mr. Brown is leasing the property, located at 2300 Lebanon Road, to Mr. Chuck Denton, owner of Buckeye Helicopter Rides. He stated that the property is zoned MXU-N (mixed use neighborhood) and this type of business in an allowable use under current zoning regulations. He then stated that Mr. Denton operates his business out of Put-in-Bay, Ohio during the months of May through September and would only be operating at the Lebanon Road address during the months of October through April.

Mr. Yetter reviewed the comments from agencies and elected officials concerned and stated his recommendation to approve the site plan subject to five conditions.

Mr. Yetter read into the record a letter from Dr. Dave and Mary Haeussler, adjacent property owners, stating that they are pro business but have concerns relative to noise.

Mr. Frank Dimos, area resident, expressed his concerns about the noise that additional helicopters in the area would create and that a business of this sort would not blend into the neighborhood. Mr. Dimos requested that if the Board approves the site plan, the hours of operation be limited to lessen the impact on the neighborhood.

Mrs. Doris Craft, area resident, stated that while she understands the need for the hospital helicopters that fly in the area, she is concerned that an additional helicopter and the noise that it brings will cause property values in the neighborhood to depreciate and urged the Board to please consider the families that live in the area and the impact this business would have.

Mr. Yetter stated that the Zoning Department has received numerous phone calls from residents regarding this matter and that most of those callers expressed their concerns relative to the additional noise that the proposed business would bring to their neighborhood.


Upon further discussion, Commissioner Young stated his desire to continue this discussion to Thursday, March 22, 2012, in order for more residents to attend.




- Sherriff's Office Replacement of Gutters where the metal rusted out.

- Budget Numbers for Roof Replacement:

- Masonry will have to be addressed as well.
- \$10,000 Price to re-line existing boxed gutters in front of the building - occupied office space.
- \$35,000 Price to re-line boxed gutters on rest of the building.




