Vicki Perry, Grants Coordinator, was present to discuss amending the agreement with Warren County Community Services relative to a Housing Project Loan through the Program Income Revolving Loan Fund.

Mrs. Perry stated that the Board entered into an agreement in January 2014, to provide a \$50,000 loan to Community Services to assist in covering the costs for rehabilitation of a home that will be sold upon completion to a low to moderate income buyer.

The original agreement stated that the loan would be repaid within 12 months. Since Community Services is utilizing labor from the Warren County Career Center Construction Technology class, it is taking longer than anticipated to complete the project.

Mrs. Perry stated that Warren County Community Services is requesting an extension of an additional 12 months to repay the loan.

Mrs. Perry stated that this matter was discussed in the last meeting of the Warren County Rehab Board of Trustees and they voted to recommend approval of the extension request.

Upon further discussion, the Board resolved (Resolution #14-2057) to approve and authorize the President of the Board to sign the Amendment to the proposal of Warren County Community Services relevant to a Housing Project Loan through the Program Income Revolving Loan Fund.

Mrs. Perry stated the need for additional repair funds by an individual for replacement of a roof.

Mrs. Perry explained that the individual in question is a 66 year old woman on permanent disability and receives approximately \$900 a month in income. She stated that the woman previously received approximately \$3,700 in CHIP funding for baseboard heating. She then stated that the roof is now leaking and needs to be replaced. The cost of the roof is \$8,000. If approved, the total amount to be repaid would be approximately \$11,700.

Mrs. Perry further stated that the individual's home is paid for so the \$11,700 would be a lien for a first mortgage which would be repaid to the County when the home is sold.

Commissioner South stated that the amount requested is less than 50% of the current value of the home and the request falls within the current program guidelines.

Mrs. Perry requested the Board's approval to increase the total available loan amount to \$12,000 to cover the additional expense of replacing the roof.

On motion, upon unanimous call of the roll, the Board directed Mrs. Perry to submit a Purchase Order for the amount of \$8,000 for the repair of the roof and increase the total amount of the lien to \$12,000.

Commissioners South and Young discussed their desire to authorize outgoing Commissioner Ariss to retain ownership of his county provided cell phone and tablet, with the understanding

that he would transfer service from the county account to his personal account.

Upon discussion, the Board authorized the Telecommunications Department to transfer ownership of the cell phone and tablet to Tom Ariss and work with Verizon Wireless to transfer said accounts associated with the electronic devices.

Commissioners Young and South wished Commissioner Ariss well in his retirement. Upon motion the meeting was adjourned.
