Duane Stansbury, Warren County Combined Health District Health Commissioner, was present for a work session to discuss the recent rules implemented by the Ohio EPA relative to "on site" sewage systems.

Mr. Stansbury explained that the new rules, effective January 1, 2015, focus on treatment vs. disposal and those sewage regulations are mostly governed by the Ohio EPA. He then explained the old process of obtaining soil samples with a caveat letter that each lot would be required to be sampled once a location of a home was established and then a permit to install would be issued.

Bobby Henderson, developer within Warren County, explained that he was given no notice of any rules change and would like to be considered for approval of an alternative, more affordable system that is approved by the Ohio EPA, rather than the mound system.

Mr. Standbury stated they have not received any requested for an alternative system but if Mr. Henderson would like to submit a design/application, they would consider it.

Dan Michael, soil scientist, stated the ability to come up with a modified system but it would require a variance to be approved.

Upon further discussion, it was determined that Mr. Henderson would submit a design application for review for his Union Township subdivision.

The Board recessed in order to deliberate a decision relative to the Sister, Ltd./Pilot Travel Center Site Plan Review application.

On motion, upon unanimous call of the roll, the Board entered into executive session at 9:42 a.m. to discuss personnel matters relative to discipline within the Water and Sewer Department and Emergency Services pursuant to Ohio Revised Code Section 121.22 (G)(1) and also recessed in order to deliberate a decision relative to the Sister, Ltd./Pilot Travel Center Site Plan Review application. The Board exited executive session at 11:16 a.m.
