The Board of Commissioners and the Warren County Airport Authority will review bids for a recommendation at a later date.

Stan Williams, Regional Planning Commission, was present along with staff and Michael Yetter, Chief Zoning Inspector, and staff, and Bruce McGary, Assistant Prosecutor, at the request of Commissioner Young to discuss zoning philosophy as it relates to high density apartments being proposed in the middle of rural areas because our zoning classification permits it.

There was a discussion relative to the increase in population and demand on government services with high density apartments as compared to the low return of tax dollars to pay for said services.

Commissioner Young stated his desire to avoid isolated pockets of high density apartments due to our choice to zone for the future.

There was discussion relative to the process of notices that would need to be followed if the Board chooses to make density changes through the text amendment process.

Commissioner Young stated he does not like apartment buildings being permitted all over the county.

Mr. Yetter stated his desire for a monthly work session to keep the Board informed of projects that staff is working on with developers.

Commissioner Grossmann stated he is reluctant to make any changes to the zoning code when people have relied upon what was in place when they purchased property.

Commissioner South stated she doesn't necessarily have a problem with property adjacent to an interstate being zoned to allow eight dwelling units per acres. She then stated the trouble with the vision for the future because of the "piece meal" puzzle in sporadic locations along the interstate.

There was discussion relative to the request for staff to review the current zoning classifications where the MXU-C and MXU-N classifications exist and follow up with this Board on any recommended changes.

There was also discussion relative to the desire of staff not to design developments on behalf of developers. The Board stated that the job of staff is to review and enforce.

Upon discussion, it was determined that a follow up work session will be scheduled once staff has reviewed the current zoning map.

#### **PUBLIC HEARING**

## CONTINUATION TO CONSIDER MODIFICATION TO THE RULES AND REGULATIONS OF THE WARREN COUNTY WATER AND SEWER DEPARTMENT

The continuation of the public hearing to consider modifications to the Rules and Regulations of the Warren County Water and Sewer Department was reconvened this 9<sup>th</sup> day of August 2016, in the Commissioners' Meeting Room.

Chris Brausch, Sanitary Engineer, reviewed the discussions from the previous public hearings and stated that this hearing was continued because of the need for a revised definition of Assisted Living and also the addition of a policy relative to reimbursement for sanitary sewer backups to be included in the regulations.

Mr. Brausch reviewed the revised definition and stated he is in agreement with the revision.

Bruce McGary, Assistant Prosecutor, stated his opinion that the Ohio Revised Code definition of Assisted Living was not appropriate and felt it more appropriate to rely upon the dictionary for the definition.

Commissioner South stated her concern that a developer may attempt to propose to define a single family residential development as an assisted living development based upon the proposed definition.

There was discussion relative to amending the definition to include the requirement of a single owner.

Mr. Brausch stated his understanding that the proposed assisted living development in Hamilton Township will not have a single owner, but rather each building could be owned by a separate legal entity.

There was then discussion relative to the need to define "group housing".

Upon further discussion, the Board resolved (Resolution #16-1237) to continue the public hearing to August 16, 2016, at 10:30 a.m. in order to further modification definitions.

On motion, upon unanimous call of the roll, the Board entered into executive session at 10:56 a.m. to discuss acquisition of property pursuant to Ohio Revised Code Section 121.22 (G)(2) and personnel matters relative to discipline in Emergency Services and specific personnel within the
