DISCUSSIONS

On motion, upon unanimous call of the roll, the Board accepted and approved the consent agenda.

Matt Schnipke, Economic Development Director, was present for a work session to discuss the request for qualifications for professional consultant services for broadband internet infrastructure project.

Mr. Schnipke stated that, upon completion of the interviews and discussion with the Board, the review committee has met and discussed the submittals and is recommending that the Board reject all of the submittals. He presented the following options relative to how to proceed:

- 1. The county could advertise a subsequent RFQ that seeks the statements of qualifications from firms that can provide project management services. A knowledgeable project manager can help assess the county's needs, develop RFP criteria which would seek specific technical proposals, conduct pre-submittal meetings, and assist in interpreting the proposals from internet service providers.
- 2. the Commissioners could hire anyone they so choose that is an engineer, consultant, or construction project manager without competitive bidding under the exception in R.C. 307.86. Because the consultant is not providing professional design services the RFQ mandate of R.C. 153.67 does not apply.

There was discussion relative to the two (2) options with the consensus of the Board being to follow a more formal process to hire an expert to write the specification that will leverage tax dollars with the funding of a provider or providers in order to get the most coverage for Warren County.

Tiffany Zindel, County Administrator, stated that there are other political subdivisions in Warren County that would like to join our project by including their ARPA funds to provide additional leverage.

There was discussion relative to the review process for the new request for qualifications.

The Board stated their desire to be involved in the final selection of the consultant.

Tiffany Zindel, County Administrator, discussed the submittals received relative to the Facilities Master Plan Study. She questioned if the Board desires to be a part of the review committee or defer to a review committee for a recommendation.

The Board stated they trust the selected staff with making the recommendation of who to select.

Mrs. Zindel discussed the Elderly Services Committee recommendation to fund a coordinator through levy dollars for the Friendly Visitor Program.

Upon discussion, the Board agreed to fund the position.

Commissioner Jones, as appointed Warren County representative, informed the Board of the One Ohio Regional 14 stakeholder meeting scheduled for later today relative to the Opioid Settlement lawsuit.

Ted Heckman, Alta Fiber (formally known as Cincinnati Bell), stated he is in attendance relative to the work session to discuss Broadband internet services and stated his company is very interested in working with the County. He provided information relative to the partnership project in within three counties in Northern Kentucky and suggested the Board contact those counties for additional information.

The Board discussed the current situation in Ukraine and their opinion relative to the need for the US to stop purchasing oil and gas from Russia which is being used to fund the Russian regime.

Upon motion the meeting was adjourned.
