WARREN COUNTY ELDERLY SERVICES ADVISORY COMMITTEE BY LAWS

ARTICLE I - NAME

The name of the committee shall be the Warren County Elderly Services Advisory Committee (ESAC).

ARTICLE II - PURPOSE

Section 1

The ESAC shall be a means by which the views of senior citizens, community leaders, individuals involved in the field of aging, and community leaders are synthesized into recommendations to the County Commissioners in determining programs to be provided by the implementation of the Warren County Senior Services Levy.

ARTICLE III - OBJECTIVES

Section 1 - The objectives of the ESAC are:

- To establish a committee of representatives of Senior Citizens, knowledgeable persons in the filed of aging, and other community representatives.
- b) To assist in the assessment of service needs and the development of program plans.
- c) To assist in evaluating the impact of the Warren County Senior Services Levy.

ARTICLE IV - STRUCTURE

Section 1 - Membership of the ESAC shall include:

- a) The President of the Board of County Commissioners or their designee.
- b) Three (3) Warren County residents age 65 years or older with each County Commissioner having one (1) appointment.
- c) The Warren County Auditor.
- d) One (1) representative from a non-profit social service agency appointed by the Board of County Commissioners.
- e) One (1) Service Provider appointed by the Board of County Commissioners.

Section 2 - Terms

- a) The Warren County resident members; the Service Provider member; and the non profit social service agency member shall be appointed for a three (3) year term of office. For said members, no individual shall serve more than two (2) consecutive three (3) year terms; however, initial terms of the Warren County resident members shall be staggered with one (1) year, two (2) year, and three (3) year terms so that an appointee is designated in each calendar year.
- b) The President of the Board of County Commissioners, or their designee, shall serve the term of their election or designation and the Warren County Auditor shall serve the term of his/her election.

Section 3 - Officers

a) The ESAC shall elect yearly from its membership, a Chair. Vice Chair, and a Secretary.

Section 4 - Meetings

- a) There shall be a minimum of four (4) meetings a year and others, as needed, determined by the Chair.
- b) A quorum shall consist of a majority of the seated members.
- c) The current edition of Roberts Rules of Order shall govern all meetings.

ARTICLE V - AMENDMENTS

These Bylaws may be amended by two-thirds (2/3) vote of the ESAC at any regular meeting provided that any proposed amendment is submitted in writing to all members of the ESAC at least fourteen (14) days preceding the meeting. The amended Bylaws must have approval by the Warren County Board of Commissioners to become effective.

ARTICLE VI - CONFLICT OF INTEREST

Membership on the ESP Advisory Council shall not redound to the advantage of the members. In the consideration of any matter, the outcome of which may result in a personal gain for a member, or the agency or organization they represent, said member shall declare the existence of conflict of interest and shall abstain from voting to decide the issue. This shall not restrict the President of the Warren County Board of Commissioners from voting on issues affecting Warren County government.
